NAME OF THE SOCIETY

The name of the Society shall be Pawan Ganga Educational Society.

REGISTERED OFFICE

The registered office of the Society shall be situated in the National Capital Territory of Delhi and is at present located at 4/12, East Punjabi Bagh, New Delhi-110026.

3. AIMS & OBJECTS

- To spread education by setting up institutions of education, training and research at all levels in the areas of professional, vocational, technical, medical, para- medical and general education including universities and other centers of higher learning;
- To impart training in Information Technology and other emerging areas of science and technology and to import equipment and machinery for this purpose;
- To provide for the education and training of women, Scheduled Castes, Scheduled Tribes, Other Backward Classes and other weaker sections of the society in existing institutions and to set up and maintain, if found necessary, separate institutions for them;
- iv) To set up and maintain hostels, canteens, clinics, tuck shops, staff accommodation and other facilities for the students and staff residing in the campuses of the institutions run by the Society;
- v) To grant scholarships and other financial aid to the students to enable them to pursue advanced studies and training in technical, commercial, management, professional and industrial education in India and abroad;
- vi) To take over or collaborate with any existing society or trust working anywhere in the world whose aims and objects are similar to those of this Society;
- vii) To set up and run agricultural farms and dairy farms with or without the help of any outside agency for imparting advanced practical training in agriculture, dairy farming and other related occupations to students, villagers, farmers and any other persons;
- viii) To sell, auction, pledge, mortgage, exchange, rent/lease out and hypothecate any movable and immovable property belonging to the Society and purchase, take on rent/lease or otherwise acquire any movable or immovable property for the Society;
- ix) To collaborate with universities and institutions other than those run by the Society in India and abroad to fulfil the aims and objects of the Society;

xii) To do all such deeds and perform all such functions as are necessary and expedient for the realization of the aims and objects of the Society as set forth in this Memorandum of Association.

4. PROPERTIES AND FUNDS OF THE SOCIETY

All the movable and immovable properties of the Society shall be utilised and applied towards the promotion of the aims and objects of the Society only, as set forth in this Memorandum of Association and no profit thereon shall be paid or transferred directly or indirectly by way of dividend, bonus, profit or in any manner whatsoever to the present or past members of the Society or to any person claiming through anyone or more of the present or past members of the Society. No member of the Society shall have any personal claim on any movable or immovable properties of the Society or make any profit, whatsoever, by virtue of his/her membership.

RULES AND REGULATIONS OF

BoyerFir of Socie

PAWAN GANGA EDUCATIONAL SOCIETY

1. Name of the Society

The name of the Society shall be Pawan Ganga Educational Society.

2. Membership and Subscription

The membership of the Society shall be open to all those persons who have attained the age of eighteen years and have been invited by the Chairman or the Secretary of the Society in writing to become a member of the Society, regardless of caste, creed, sect or religion subject to the approval of the Governing Body by at least a three-fourth majority and the consent of the Chairman of the Society.

3. Categories of Members and Membership Fee

The Society will have the following categories of members:-


- a) Members
- i) Members shall be those who apply on invitation to the Secretary of the Society in writing for membership and who are admitted as Members by a minimum of three fourth majority of the Governing Body with the consent of the Chairman.
- ii) Each Member shall pay a life-time membership fee of Rs. 2,50,000.00 (rupees two lakh and fifty thousand only).

b) Ordinary Members

- The Governing Body may admit, by at least a three fourth majority, any person found suitable by it who fulfills the eligibility criteria laid down in clause 2 above and who is interested in the objects of the Society, as an ordinary member. However, no person shall be admitted as an ordinary member of the Society without the consent of the Chairman and no ordinary member shall retain his or her ordinary membership of the Society for more than one year.
- ii) Ordinary members shall not be required to pay any admission fee or membership fee.
- (iii) Ordinary members shall be entitled to attend the meetings of the General Body and participate therein subject to the rules and regulations of the Society framed from time to time, but shall neither have a right to vote nor to elect the office bearers and nor shall they be eligible to hold any office of the Society

4 Patrons

a) Persons of eminence and integrity in public life and persons having special interest in the activities of the Society, may be admitted as Patrons by the Governing Body for a specified period not exceeding three years on such terms and conditions as the Governing Body may decide in each particular case.

b) Patrons will not be required to pay any admission fee or membership fee

Patrons shall be entitled to attend and participate in all the General Body meetings of the Society subject to the rules and regulations of the Society framed from time to time but shall neither have a right to vote nor to elect the office bearers and nor shall they be eligible to hold any office of the Society.

5. Enrollment

All the applications for membership and ordinary membership of the Society except in the case of Patrons, will be addressed to the Secretary of the Society who, after satisfying himself that the applications are in order, shall place the same before the Governing Body for its consideration. The decision of the Governing Body, taken by at least a three-fourth majority with the consent of the Chairman regarding such applications, shall be final.

6. Cessation of Membership

- Any Member or ordinary member can withdraw his/her membership through a written resignation duly signed by him/her and submitted to the Secretary of the Society. The resignation shall take effect from the date of its acceptance by the Governing Body with a simple majority with the consent of the Chairman.
- b) The Governing Body may expel any Member or ordinary member from the Society by at least a three fourth majority of the total membership of the Governing Body with the consent of the Chairman, if
- i) it is satisfied that the Member or the ordinary member concerned is acting against, or that the continuance of his/her membership is detrimental to the best interests of the Society or the objects of the Society;
- (ii) he or she is adjudicated an insolvent by any competent court of law; or
- iii) he or she has been found guilty of an offence which, in the opinion of the Governing Body, involves moral turpitude or dishonesty.
- However, before a Member or ordinary member is expelled, he or she shall be given in writing the grounds of expulsion and also given an opportunity to explain or clarify his or her position.

7. Re-Admission

The Governing Body, by at least a three fourth majority and with the consent of the Chairman, may employ its discretion to re-admit such Members or ordinary members as are willing to be readmitted to the Society.

8. Register of Members .

The Society shall maintain a membership register in which names, addresses and occupations of the Members and the ordinary members shall be recorded.
